- 4. I understand that I must keep current and present a copy of my vehicle insurance w/ coverage to \$100,000 in property damage.
- 5. I further understand that my authorized area is to and from aircraft, entering and exiting by using the closet operable gate to my destination. These Gates are limited to Gate 10, or 14 only.
- 6. Any violation / deviation from authorized area will result in the immediate suspension or revocation of privileges.
- 7. I understand that I must wear my badge above the waist on my outermost garment and display it upon request to any other ORH or MAC badged individual or Airport Representative.
- 8. I understand that any changes to my information above, lost airport property (badges, gate cards, stickers, etc.), and airport emergencies will be reported to the Airport Police 508-799-1349 immediately.
- 9. Just prior to expiration of my Vehicle Access Sticker (yearly) or GA Airport Badge (every two years from issue date) I will return to the Airport Police Station for renewal.
- 10. If my need for access to the Worcester Regional Airport General Aviation Areas ends, I will return all Airport Property (badge, gate cards, stickers, etc.) to the Airport Police Station, immediately.
- 11. The first time I require a re-placement ID, the charge will be \$50. After the first replacement the Airport Director reserves the right to suspend my ID privileges.
